1. Applications are invited from the eligible candidates for appointment to the post of Professors at Government Medical College : Piduguralla, Palnadu District
2. Recruitment is on a **CONTRACT BASIS** for a period of minimum one year and which is extendable till regular candidates available. On arrival of regular candidate after one year, the appointment shall come to an end.
3. Recruitment shall be as per the service rules issued in the G.O.MS..No.21, HM & FW (A1) department, dated 07-02-2024 and Teachers Eligibility Qualifications in Medical Institutions Regulations issued by NMC from time to time.

**4. Total Number of Vacancies : 6.**

- Vacancies are tentative and may increase or decrease.

5. Outside state candidates should get their qualification registered from Andhra Pradesh State Medical Council within one week of selection, for their appointment to be confirmed.

7. **Eligibility qualification:**

8. **HOW TO APPLY :**

- ii. The candidates shall have to pay the application Fee Rs.2,000/- for OC Rs.1,800 /- for BC, SC, ST, EWS and Differently Abled persons.
- iii. Payment shall be done in Online Mode only at the time of Walk-in-Recruitment

9. **Selection Criteria –**

1. 50% of the total marks would be considered as the criteria for eligibility for selection.
2. The duration of their teaching experience in the cadre of Professor & Publications (minimum 4) in that Cadre will be considered for Selection.
3. DNB Candidates will be selected as per the latest existing NMC guidelines.

**Note:**

1. Selection of candidates will be Nationwide (first preference is given to the local candidates. If local candidates are not available candidates from other states will be considered.

➤ **Definition of Local Candidature**

- I. Candidates who studied from 4<sup>th</sup> Class to 10<sup>th</sup> Class in the State of A.P and Candidates who migrated to any part of AP from the State of Telangana within a period of 3 years from 2<sup>nd</sup> June 2014. (As per G.O. No.132 GAD Dt.13-06-2016 & G.O. Ms. No.133 GAD Dt.13.06.2016) are considered as Local.
  - II. The Residence Certificate/ Nativity/ Domicile Certificate issued by MRO/ Tahsildar will not be allowed for Local consideration without mentioning the G.O. No.132 GAD Dt.13-06-2016 & G.O. Ms. No.133 GAD Dt.13.06.2016 for the candidate who studied in the State of Telangana before bifurcation.
  - III. The Residence Certificate will not be accepted if a Candidate has studied in any Educational institutions up to SSC or equivalent Examination; such candidates have to produce study certificates in variably.
2. The age of the applicant should be below 69 years on the day of Notification.
  3. The selected candidate will have to submit the relieving order from their previous institute, failing which their selection will stand cancelled.
  4. The candidates who are working in any other Government Medical Colleges of Andhra Pradesh on Contract basis as Professor are not eligible to Apply.
  5. **During the period of contract, the faculty will be paid a consolidated monthly remuneration as per GO. MS.No.21 Health, Medical and Family Welfare (A1) department, Government of Andhra Pradesh, dated 07/02/2024. The remuneration shall be all inclusive and subject to deduction of tax at source and/ or any other statutory deductions to the extent required under the laws. In addition to the above no other allowances like D.A, N.P.A, HRA etc. would be payable.**
  6. In view of single post, Rule of reservation (ROR) shall not be applicable.
  7. No TA/DA will be admissible for interview or joining.
  8. No claim for any services like PF, Pension, Gratuity, and Medical allowances, Seniority, Promotion and other Leaves will be admissible.
  9. Application fee once paid will not be refunded under any circumstances.
  10. Retirees from Central/State Govt./PSU from the equivalent posts are eligible to apply and will be given first priority. Persons working in recognized / approved private Medical Institutions fulfilling eligibility criteria for the post may also apply.
  11. Government reserves right to cancel the recruitment process at any stage at its discretion and such decision will be binding on all concerned.

**10. Terms and Conditions:**

1. The selected faculty will be eligible for fifteen (15) days leave in a calendar year on cumulative basis. No other leaves are permissible.
2. The appointment as contract employee is purely on temporary basis for a period of one year from date of joining and there after extendable on satisfactory performance subjected to approval of the Competent Authority till the vacancies are filled by promotion with regular Government employees. This contract placement does not confer any right for future Government appointment.
3. The contract is liable to be terminated at any time with a one-month notice during tenure period, if any misconduct is noticed. If the candidate wants to discontinue he/she shall inform one-month before.
4. The engaged faculty will be at the disposal of the institute on whole time basis and his/her service may be utilized in any manner required by the Competent Authority of the Institute without any claims for any additional remuneration.
5. Candidates should submit a self-declaration at the time of joining that no criminal cases are pending.

6. The decision of the committee is final and<sup>4</sup> binding.
7. The selected candidates shall be enrolled in NMC AEBAS attendance and attend the college and hospitals as per timings i.e. 9 AM to 4 PM.

**11. General instructions:**

- a) The original certificates MBBS, MD/MS/DNB degree along with MBBS registration and MS/MD/DNB Degree registration, publications, BCBR and BCMET have to be produced at the time of joining during certificate verification.
- b) Applicants should make sure of their eligibility to the posts applied for and that the declaration made by them in the application form regarding their eligibility is correct in all respects. Any applicant furnishing incorrect information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from appearing for any of the examinations conducted by the APMSRB, and for summary rejection of candidature for this recruitment.
- c) The Board is vested with the duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process. Any attempt by anyone causing or likely to cause breach of this duty or by any action which violates or is likely to violate fair practices followed and ensured by the Board will be sufficient cause for rendering such action as ground for debarment and penal consequences as per law and rules shall be involved as may be decided by the APMSRB.
- d) The APMSRB/ DME reserves every right to cancel the Notification / alter / modify any condition laid down in the Notification for final selection and also number of posts notified.
