In the reference 1st cited, this office has issued admission notification for General Nursing and Midwifery Course (3 years) for the Academic year 2025-2026 batch which is being imparted in Government and Private Schools of Nursing in the state.

In the reference 2nd cited, the General Secretary, Andhra Pradesh Nursing Institutions Management Association have given a representation to the DME for extension of dates for payment of Registration fee and online submission of applications. This office vide reference 4th cited considered the request made by the General Secretary, Andhra Pradesh Nursing Institutions Management Association, extended the last date for payment for registrations, submission of applications till 25-10-2025 and completion of admission process till 31-10-2025.

Further, it is to inform that vide reference 5th cited, the General Secretary, Andhra Pradesh Nursing Institutions Management Association has given another representation to the DME for extension of dates till 30-11-2025 as the INC has extended the last date for admissions and also stated that the BSc (N) counseling is not yet started and the candidates who did not get the seats in BSc (N) course will join in GNM course and requested to extend till 30-11-2025 for payment of Registration fee and online submission of applications.

In this context, Indian Nursing Council, New Delhi vide notification No 13 of 2025 has extended the last date of admission to nursing programs i.e ANM, GNM, B.Sc (N) for the academic year 2025-26 till 30th November 2025. And also mentioned that the total number of students admitted up to 31st October (Regular batch) and 30th November 2025 (irregular batch) should add up to the sanctioned strength and shall not exceed the Annual intake.

In view of the request made by the Andhra Pradesh Nursing Institutions Management Association, AP., the admission schedule is revised as follows:

1. Payment of Registration fee for private institutions are extended up to 25-11-2025.
2. Online submission of applications and submission of downloaded applications are extended up to 25-11-2025 till 5.00 P.M. for private schools Convener Quota.
3. Online submission of applications and submission of downloaded applications are extended up to 25-11-2025 to 5.00 P.M. for private schools Management Quota.
4. Selection process should be completed by 29-11-2025 for Private Schools by DM&HOs.
5. Commencement of classes will be from 01-12-2025.

For further details, contact concerned Superintendents Government General Hospital, attached with Government School of Nursing, in respect of Government Schools of Nursing, and contact concerned District Medical and Health Officer, in respect of Private Schools of Nursing. Further, all the DM&HO's are requested to upload the selection list of GNM students in the DME website i.e within one week as per the instructions of Indian Nursing Council, New Delhi.
